- e) Trade License in respect of the prospective Bidder, Proprietorship Firm (Trade License), Partnership Firm (Partnership Deed, Trade License) Ltd Company (Incorporation certificate, Trade License), Co-operative Society (Society Registration copy, Trade License).
- f) GST Registration Number Certificate
- g) Attested copies of credentials towards satisfactory performance in the format of work completion certificate indicating Name of the Work, Ordered Amount, Executed Amount, date of commencement and completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer/Assistant Engineer or equivalent rank and above will be treated as valid credential in support of execution of similar nature of work having magnitude of at least 50% of Estimated Cost only in a single order during the preceding 3 years are also to be submitted. Also, submission of copy of work order and schedule of work as supporting documents of completion certificate is mandatory. Original documents are to be provided for verification on demand

The Building & Other Construction Workers (Regulation of Employment & Condition of Service) Act, 1996 will be applicable as per provision of the act.

The tender under sealed cover will be received at the office of the undersigned up to 14:00 hrs on 20/10/2022 (in tender box) and will be opened on the same day at 15:00hrs in presence of the attending tenderers or their authorized representatives.

Before submission of the tender, the tenderer should inspect the site to get acquainted with the nature of work. Tender containing extraneous condition should not be accepted. Offered rate should remain valid for 180 (One Hundred Eighty) days from the date of opening of the tender.

The quoted price should be firm. GST will be paid extra as per rules but should not be included in the quoted price.

The successful contractor shall, within a specified time of the receipt of the Letter of Intent / Erection Order, execute an Indemnity Bond with the WBSEDCL in specified format.

Not with standing anything stated above, WBSEDCL reserves the right to assess the capacity and capability of the bidder to execute the work, should the circumstances want such assessment in the overall interest of WBSEDCL.

Even though the bidders meet above qualifying criteria, they are subjected to be disqualified if they have either made misleading or false representations in the forms, statements and attachments submitted in proof of the qualifying requirements and / or record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completions, litigation history or financial failure.

Formation of any cartel, may lead to the cancellation of tenders with penal measures as necessary and WBSEDCL reserves the right to take such unilateral decisions without further notice to anyone.

WBSEDCL does not bind itself to accept the lowest offer and reserves the right to reject any or all the offers without assigning any reason whatsoever. WBSEDCL also reserves the right to split the work in parts among the bidders and to cancel the order, if placed, at any time after placement of the order after giving 14 (fourteen) days' notice.
