3. Eligibility criteria for participation in tender

- i. For Sl.no.1- Three similar nature of works (Sub Station/switchyard related works) costing not less than the amount equal to 40% of the estimated cost in separate three contracts/Two similar works (Sub Station/switchyard related works) costing not less than the amount equal to 50% of the estimated cost in separate two contracts /One similar work (Sub Station/switchyard related works) costing not less than the amount equal to 80% of the total estimated cost in single contract after 1st April, 2018. The Credentials will be construed upon the executed value of work duly certified by the concerned Departmental head supported by payment certificate. If the status of the work, for which the credentials are submitted, is on progress, then the credential will be construed as the gross value of RA bills released by the concerned Department, in a form of payment certificate. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. [Non-statutory Documents].

For Sl.no.2&3- All categories of intending Bidders who have satisfactorily completed:

3.1.1.

a) Three similar nature of works costing not less than the amount equal to 40% of the estimated costing separate three contracts.

3.1.2. Completion Certificate indicating Estimated Amount, value of work-done, Date of completion of the work and detail communicational address along with contact number of the Client should be submitted by the Bidder. Completion Certificate from the concerned Executive Engineer/District Engineer/Divisional Engineer or equivalent rank and above will be treated as valid credential. [Non-statutory Documents]

3.1.3. The bidder must have full-fledged set up for executing similar projects. Details of execution set up to be deployed by the bidder shall be furnished in their offer. Management team shall be headed by Manager who shall have at least 2(Two) years of experience (including 7A , 7B & 7C license) in execution of such contract of comparable nature. He shall be stationed at work site.

3.1.4. The Bidder must submit exhaustive list of Erection Tools and Equipment's for execution of the work.

Such abandonment or rescission will be considered as disqualification towards eligibility. (a declaration in this respect has to be furnished by the prospective bidders). [Non-statutory Documents]
 - v. No conditional / Incomplete Tender will be accepted under any circumstances.
4. The **FINANCIAL OFFER** of the prospective bidder will be considered only if the **TECHNICAL BID** of the Bidder is found qualified by the WBSEDCL. The decision of the WBSEDCL will be final and absolute in this respect. The list of Qualified Bidders of Technical Bid will be displayed in the website.
 5. No mobilization advance and secured advance will be allowed.
 6. A prospective Bidder shall be allowed to participate in the tender either in the capacity of individual or as a partner of firm. Joint Venture/Consortium shall not be allowed. If found applied severally in a single job, all his offers will be rejected for that job.
 7. Bid shall remain valid for a period not less than 180 (one hundred eighty) days from the date of opening of Financial Bid. If the bidder modifies/withdraws the bid during the interval between the deadline for submission of bids and the expiry of the period of bid validity, the bid will be cancelled with forfeiture of earnest money deposit (EMD).


