- III. **Payment:** 100% Payment will be made within 45(Forty Five) days after submission of the Bill. Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency. Payment will be made through R.T.G.S/N.E.F.T (R.T.G.S/N.E.F.T charge to be borne by the Agency).
