- II. **Price**: Price should be firm inclusive of all incidental charges and transportation charges. GST value and percentage to be written separately in quotation. However GST will be applicable as per law of land at the time of placement of order. STDS will be deducted as per norms.
- III. **Payment**: 100% Payment will be made after submission of the Bill. Bills in triplicate along with challan in triplicate and advance pre-receipt copy with revenue stamp must be given by the Agency. Payment will be made through R.T.G.S/N.E.F.T (R.T.G.S/N.E.F.T charge to be borne by the Agency).
