- ii) All categories of prospective Bidders shall have to submit valid copies of up to date Professional Tax receipt Challan upto the period 31.03.2021, E.P.F. Registration Certificate, GST Registration Certificate, GSTIN, PAN Card and Income Tax Return for last three financial years, Trade License in respect of the prospective Bidder. Proprietorship Firm (Trade License). Partnership Firm (Partnership Deed, Trade License). Ltd. Company (Incorporation certificate, Trade License). Co-operative Society (Society Registration copy, Trade License). Bidders without valid E.P.F. registration no. will be summarily rejected. [Non-statutory Documents]
- Neither prospective Bidder nor any of the constituent partners had been be barred to participate in any Tender by any Government Department / Semi-Govt. / Govt. Undertakings / Enterprise etc. during the last 3(three) years prior to the date of this NIT. Such debarring will be considered as disqualification towards eligibility. - 13. Conditional / Incomplete tender will not be accepted under any circumstances.
- 14. The intending Bidders are required to quote the rate online only. The Price bid in Offline submission shall not be entertained.
- 15. During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other paper found incorrect / manufactured / fabricated, that bidder would not be allowed to participate in the tender and that application will be rejected without any prejudice.
